

Dental Simulations Privacy Policy

This privacy policy sets out how Dental Simulations, LLC uses and protects any information that you give Dental Simulations, LLC when you use this website.

Dental Simulations, LLC is committed to ensuring that your privacy is protected. We ask you to provide certain information by which you can be identified when using this web site. You can be assured that it will only be used in accordance with this privacy statement.

Personal Information

The website will collect and maintain some personal information provided by its users. This includes their name, a User ID, a password, school of attendance, and an email address, that you (the User) provide when you register on the website. The User cannot effectively use the website unless they provide this information. This web site does not integrate with your university email or other accounts. Your Game Administrator (Instructor or Professor) has access to the information you provide to the website.

You can correct, update, or change your personal information, by logging into your account and clicking the "Manage Profile" tab. You can opt out of the limited email communication system built into the web site when you receive an email. You also have the ability to disable your account, in accordance with the Terms of Use. However, you will not be able to use the website if you disable your account.

How we use the information

The information that you provide is only used to allow you to access the web site for use in your educational program.

If you message the website with questions concerning the use of the website, we will use your information to respond to you. We might use personal information for periodic general announcements to users. These can include notifications, updates concerning the website, or other site-specific notices.

Your Game Administrator may use the limited email system included in the web site to relate information concerning your ongoing event, or information concerning your class or curriculum. We do not retain this information.

Cookies

We do not use cookies on our website www.dentalsimulations.com.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online. However, it is impossible for us to

Usage and Analytics Data

We may collect usage information to determine how users access the site. We use this data to improve the site's functionality.
